The current location of the Burbank Chamber of Commerce offices was established in 1947 when the Burbank Water & Power Department sold the site at Magnolia Boulevard and Lake Street to the organization. After construction of the original Chamber offices in the 1950's, remodeling activities in the 1960's were undertaken to accommodate the growth of the organization. The facility as it currently exists has been in place since the 1970's; and, over the past 15-20 years some of the maintenance activity on the building has been deferred. A number of areas of the current facility have been identified for repair, replacement or upgrading including a new roof; exterior painting; fresh landscaping; and, 21st century office technology systems. The Board of Directors approved a combined financing/capital campaign plan at its September meeting and a Capital Improvement Committee (CIC) co-chaired by Jim O'Neil and Ken Nielsen will oversee the project.

As part of the capital campaign, the Board has set a goal of \$150,000 in cash and in-kind support from Chamber members. The CIC will be rolling out a specific plan which will include a compelling case statement for the project; lead gift opportunities; naming rights on key facilities; a campaign Kick Off event; in-kind contribution options for Chamber members; a recognition program for all participating members; and, volunteer opportunities for interested Chamber members.

When this project is completed, the Burbank Chamber of Commerce will have a facility to share with the broader community consistent with the prominence of its premier business base. Become an active part of this important endeavor – and be recognized for it – so future Burbank business leaders will have a clear pathway to follow....



Over the past year I have been asked, "Do you truly believe 100% of Burbank Unified School District (BUSD) students can graduate?" My answer is a simple, "Yes!"

All of us at the Burbank Unified School District (BUSD) are focused on supporting our students to help them graduate. As BUSD employees we realize that we have a unique role in guiding each student through his or her educational journey. Our focus is to help each student graduate high school in four years, but we realize that some students may need longer to finish the requirements necessary to receive a diploma or certificate of completion.

Our collective charge is to listen to our students to better understand their personal stories so that we can support them.
